Gifts include any free item or hospitality Council Members may be offered in connection with their role as a Council Member.

Benefits include any preferential treatment, privileged access, discount, favour or other advantage offered to Council Members that may be perceived as influencing the discharge of their public duties.

Register of Council Members Gifts & Benefits 2022 / 2023



Gifts and benefits can comprise:

- Complimentary or discounted accommodation, travel, entertainment, hospitality, memberships, services, or products
- Supply of goods or services at concessional prices
- Payment for speaking at or attending events
- Items of historical, cultural or commercial value

Council Members should only accept a gift or benefit in narrow circumstances. These circumstances are generally limited to offers of common courtesy, small tokens of appreciation, or low value mementos.
