Hereby apply to Alexandrina Council for a Commercial Trading Permit to place goods, as identified below on part of the road reserve adjoining the boundary of the above business pursuant to Section 222 of the Local Government Act 1999, for Street Trading Purposes.

You must ensure that a clear and unrestricted public access walk through of no less than 1.5 metres in width, is retained at all times along the footpath across the entire frontage of your business. Please ensure this is provided for on your plan.

Outdoor dining

I request permission to place tables and chairs on the footpath adjoining my above business frontage.

Display of goods or overhanging articles (for sale)

I request permission to place Furniture Flowers Clothes Other on the footpath adjoining my above business frontage.

I have attached a plan of the proposed location and layout of the tables and chairs or goods for sale.





NOTE: Where this Application requires an Alteration to a Public Road as below, the issuing of this Permit also includes an Authorisation pursuant to Section 221 of the Local Government Act 1999. (Tick whichever apply).

- Alter the construction or arrangement of the road to facilitate access to/from property
- Erect or install a structure (including pipes, wires, cables, fixtures, fittings or other objects) in, on, across, under or over the road;
- Change or interfere with the construction, arrangement or materials of the road;
- Change, interfere with or remove a structure (including pipes, wires, cables, fixtures, fittings or other objects) associated with the road;
- Plant, interfere with or remove a tree or vegetation from the road;
- Extend the business of a restaurant or café to outside tables situated on a footpath or roadside.
- Carry on a non-food business from a portion of road related area.

Note 1: The Act provides that a road extends from property boundary to property boundary and includes the carriageway, footpaths and verges.

Note 2: Pursuant to the Act, it is an offence to make an alteration to a public road without an Authorisation to do so from the Council.

SPECIAL CONDITIONS OF PERMIT: (Please read, and tick to agree)

- I agree to operate under the conditions of this permit during the opening hours of the business to which this permit applies only
- I agree to the permit zone as identified in Annexure A of this permit or request consent to the location plan attached to this application.
- I have attached a copy of my insurance in accordance with the Terms and Conditions of this permit. I confirm that the insurance attached is adequate in providing the appropriate insurance cover for those items permitted within the permit zone. I understand that Council holds no responsibility for determining the validity of the insurance provided.
- I understand that this permit does not provide me with exclusive use of the permit zone and as such, I acknowledge that other traders may be located in relatively close proximity to the location of this permitted activity.
- I understand that a condition of this permit is the requirement for a clear and unrestricted walk way for public access of no less than 1.5 metres in width to be retained at all times along the footpath area adjacent to my property/business.
- I agree to only place infrastructure in the permit zone approved by Council on Annexure A
