Chief Executive Officer's - Quarterly Update

October to December 2018

Welcome to the second quarter report of Council's highlights and achievements in 2018-19.

We had a great start to a number of initiatives in the first quarter and have completed, continued and commenced a new round of key projects in this second quarter.

The 2018 Council Elections were held in November, welcoming eight new Elected Members to Council. We ran successful Meet-the-Candidates sessions in the lead-up which were well supported by the community.

We announced the recipients of Council's 2018-19 Community Grants in October, and are pleased to report that over twenty clubs and community groups received funding to support projects and/or programs that enhance quality of life and deliver services to our community. We also supported Anti-Poverty Week in October, collecting generous contributions in the form of non-perishable foods, to support those in need.

In December, we launched a new tourism website to showcase Alexandrina, and released the seventh 'Just Add Water' Arts and Culture Program. We look forward to presenting a huge program of 85 performances and exhibitions to be hosted throughout eighteen venues across nine townships in Alexandrina.

Civil and landscape works to beautify Strathalbyn's Sandergrove Road commenced in October, and we also completed a four-year project to replace parts of the retaining walls along the Harbourmasters Walking Trail in Port Elliot at the start of the quarter.

In terms of looking after our natural environment and enhancing biodiversity, we had a number of successful events as part of the Sustainable Spring initiative and received an award for the Gazania Free Goolwa campaign at the 2018 KESAB Sustainable Communities Awards.

Council's 2017-18 Annual Report was released in December 2018, which provides a summary of Council accomplishments over the 2017-18 financial year.

I look forward to informing you of project updates again next quarter.

Implement strategies to support values engagement and a positive workplace culture

Alexandrina Council continues to seek and implement strategies to engage staff as part of the XLR8 Alex model and our commitment to our Mission, "Be Involved".

Implementation of our Innovation Hub is an important step in recognising and responding to the feedback from our staff during change consultation. As a result, we were pleased to hold our first Innovation Hub session, with guest speaker, Elaine Bensted, CEO Adelaide Zoo's who spoke about transforming organisation and culture from depress to success. Her words and examples provided inspiration for our staff to start thinking about innovation and what it means to them.

The positive impact that the Innovation Hub had on staff was evident when the following day the staff lunchroom chalkboard asked, "Innovation is.....?". This was quickly filled with a range of staff comments and quotes about what innovation means to them and provided useful feedback for future organisational development programs. The next Innovation Hub will feature speakers from the Public Sector Innovation, ICT and Digital Government, Department of the Premier and Cabinet, who will share their experience of 90 Day Projects and their effect on organisational change and the development of self led teams that generate innovation and accountability. It is expected that from this innovation hub a framework for implementation of 90 Day Projects within Alexandrina Council will occur with the first 90 day project team to be established in early 2019.

Provide open and accessible Human Resource services across the organisation

The People Department provided high level support on a number of performance management/employee relations issues resulting in changes to work methods and behaviours to meet performance expectations. The Group Manager people has regular scheduled meetings with General Managers and Managers in order to support people issues and strategies.

Staff also use the People Department as a resource for advice in relation to employee relations issues, work life balance and career planning. It is very pleasing to see so many staff accessing the department to set a strategy in place for furthering their career in Alexandrina Council.

The People Department has also supported the Executive Team in reviewing and benchmarking Manager classification and KPI criteria as part of the ongoing structural development within the framework of XLR8Alex. These changes will provide a platform for increased performance and strategic input from managers to support the organisations objectives.

Recruitment has been a key focus on the People Department in 2018 with many internal secondments creating need for back fill, a number of retirements and unplanned vacancies as well as new positions. The People Department supported the recruitment of 45 positions, reviewing over 780 applications, the approximated cost of outsourcing this service would be in excess of \$245,000.



Work Health Safety

Monitor and review Council's Health and Safety Management System

Council achieved 88% compliance on the LGAWCS KPI plan for 2018. This compares to a score of 84% in 2017 and is indicative of the organisations strong focus on a culture of health, wellbeing and safety. The People Department reviewed the systems currently used to manage information, generate reports and provide information related to WHS Training Needs Analysis and compliance with mandatory safety training. The growth of the organisation and the maturity of the WHS system has created a need to implement improved information management models to support the framework of the WHS system and maintain compliance and continuous improvement with self insurance requirements. People Department have reviewed the use of the SKyTrust system used by 68 councils and will report to Executive with recommendation to implement this system in 2019. Implementation of the system will provide costs savings (the system is provided by LGAWCS at no cost) as compared to licencing of the current systems and will eliminate risk associated with continued use of methods and systems that do not match the size and requirements of the Alexandrina Council's workforce and WHS system.

Council's Environmental Biodiversity Team has fostered relationships with community groups to support local biodiversity including:

- * Goolwa to Wellington LAP "A River Near You" event in Strathalbyn along the Angas River Corridor and saw completion of revegetation project on council land surrounding Tokuremoar Reserve.
- *Worked in collaboration with Friends of Point Sturt with ongoing weed control of reserve as per management plan.
- *Worked in collaboration with Clayton Bay Nursery and Environment Group with ongoing weed control of revegetation areas as per management plan.
- *Worked with and supported Trees for Life on ground activities.
- *Supported local Community Nurseries by purchasing stock for our revegetation projects.
- *Supported recipients of Community Environment grants.
- *Ongoing partnering with NRM Adelaide and Mount Lofty Ranges regarding weed control on roadsides and coastal weed management in addition to planning for planting project at Middleton in winter.

Managed and maintained assets in the Coastal and Riverfront areas:

- *All immediate inspection defects on Coastal and River front infrastructure have been repaired or put forward for renewal.
- *Spring/Summer weed and mowing management program is in progress.
- *Fire management program for Ratalang Bashams Beach Conservation Reserve completed prior to fire season commencing.
- *Replaced a section of coastal fencing at Horseshoe Bay that was damaged during the November storms.

Managed and maintained urban and rural biodiversity reserves:

- *The 2019 planting program covers 26 locations with approximately 4000 plants.
- *An additional 25 roadside marker sites have been added to the 18/19 program resulting in approximately 21 kilometres of selected weed control. An addition of 6.7 hectares has been included to the rural biodiversity reserves and 0.8 hectare to urban biodiversity reserves.
- *Weed control contracts for the roadside marker program is part complete.
- *Direct seeding of the Builders Cell and Goolwa Waste Depot has been completed and weed management implemented.
- *Urban and Rural reserve fire management program complete.
- *Pre inspections for tree trimming program Native Vegetation referrals is in progress.
- *Swamp Road Landscape Hydrology decommission/remediation and restoration options project is due for completion at the end of January.

Community Connect

Advocate for and provide equitable, accessible and appropriate programs and facilities through Alexandrina Council's Community Connect Services

Council's Community Connect programs provide access to social support and transport. During the July to December 2018 quarter, 417 people over the age of 65 have received at least one service from Community Connect, with over 760 hours of individual contact and 6,495 hours of group social support. There were 1,940 transport services which include attending social activities, medical appointments and shopping support.

Community Connect programs, including domestic assistance and home maintenance, support people remaining independent in their homes.

In this quarter, Community Connect provided 376 hours of domestic assistance in the Strathalbyn region. While 212 hours of home maintenance was provided across the council area.

The recent 'We Hear You 2' project recorded the moving and insightful stories of grandparents caring for grandchildren, and provided many opportunities for social connection, support and connection.

Community Development, Partnerships & Advisory Services

Advocate for equitable and accessible community facilities to support existing and future needs of the community

Council continues to collaborate with Strathalbyn's Neighbourhood Centre and Senior Citizens Club to ensure proposed building modifications meet the needs of user groups. Construction is slated to be completed in 2019.

Supported by Council, the Strathalbyn Woodshed is now fully functional from its new facility and recently received a Commonwealth grant to install solar panels on the roof of the new shed. The group is actively working with the community to facilitate additional programs from the site, and to progress plans for self-management in 2019.



Advocate for equitable, accessible community services, programs and initiatives

Council monitors, supports and contributes to the regional Positive Ageing Taskforces and regularly attend meetings with the both the Fleurieu and Hills taskforces, and support implementation of community wellbeing projects. For example, the Caddy Project, funded through the Office for The Ageing, and a collaboration of staff, volunteers and participants developed a model of support to enable a person living with dementia to connect with meaningful activities.

Support the delivery of community programs and initiatives provided through local community groups, centres or organisations

Council staff curated a portfolio of community-based events in this quarter, including for Mental Health Week, White Ribbon Day and Anti-Poverty Week, partnering with Growing Life Connections. Working closely with churches, schools, businesses to collect food for those in need in our community. As a result of the food drive, we received almost 1,600 non-perishable food items and just over \$400.00. The items and funds were shared with community groups and organisations that provide emergency relief to people across the region including the Milang Old School House Community Centre, South Coast Christian Community Care, St Vincent de Pauls, Strathalbyn Country Life Compassion and the Strath Neighbourhood Centre. Donations of breakfast items were forwarded to breakfast clubs at schools across the region.

Community Health, Sport & Recreation Services

Encourage participation in sport and recreation through supporting well managed and sustainable clubs and facilities

The Star Club Officer has been working with Alexandrina clubs to apply for grants in Round 45 of the Office for Recreation Sport and Racing's Active Club Program. The following clubs were successful in obtaining grants:

Langhorne Creek Netball Club - Court Resurfacing and Fencing - \$25,000
Port Elliot Tennis Club - Court Lighting Stage 2 - \$25,000
Strathalbyn Tennis Club - Tennis Backstop and Fencing Replacement - \$10,000
Southern Breakers Soccer Club - Program & Equipment Funding - \$5,000

Council's Environment Division commenced stakeholder consultation as the first stage of informing the Goolwa Central masterplan.



Community Transport

Support and advocate for equitable, accessible and reliable regional community transport services

The Manager Community Wellbeing is a committee member of the Southern Community Transport Scheme and the Hills Community Passenger Network. Both services have recently received growth funding from the Federal Government to assist with increasing demand for transport services for the aged, frail and transport disadvantaged in our communities.

The Hills Community Passenger Network is also procuring an additional two vehicles to be located in Strathalbyn and Gumeracha which will improve the availability of transport services in the Strathalbyn region.

Hills Community Transport will be trialling a shopping bus run in Strathalbyn in 2019 in collaboration with the Community Connect program. The Community Connect program has been successful in gaining additional funds of over \$8,000 to provide additional transport services through the Commonwealth Home Support program.

Family & Youth Services

Plan for future delivery of services, facilities, projects and programs to support youth development in Strathalbyn and surrounding townships

Working in collaboration with neighbouring councils to plan, co-ordinate and support youth initiatives and events across our region, this quarter's activities included facilitation of Strathalbyn Community Youth, facilitating youth workshops on journaling and event planning, and the establishment of a new Youth Writing Group in Strathalbyn.

Provide planning, development and coordination of services, facilities, projects and programs for youth development and retention across the region

Coordination and support for collaborative youth initiatives across the region include the "Wet Paint" youth theatre program, Blue Light Discos, and the Youth Advisory Committee (YAC). The YAC created two curated 'Escape Room' programs in the October school holidays, attended by 105 young people. Acknowledging their increased activities and facilitation roles, YAC members have undergone training programs over the last quarter, including SAPOL Volunteer Training, Child Safe Environment, and Senior First Aid. YAC members assisted with the Youth Showcase Extravaganza, the Regional Youth Art Exhibition and National Youth Week.

Community Safety

Deliver an effective and efficient operational community safety service

Animal management:

In response to community consultation, Council's Community Safety team, in collaboration with the Friends of the Port Elliot Dog Park and Greyhound Adoption Program South Australia, sought approval from the Dog and Cat Management Board to undertake a trial for greyhound-only events at the Port Elliot Dog Park. This initiative is a first for South Australia as, under state legislation, greyhounds are not permitted to run around off-leash outside of their own property. The Dog and Cat Management Board has given approval for this trial for a period of six months. One event per month has been scheduled for February - July 2019. All six events have completely booked out, which shows the amount of interest in the initiative.

With the implementation of Dogs and Cats Online (DACO), approximately 63% of dog owners either renewed their dog's registration or registered their new dog online, which significantly reduced the amount of time our customer service staff previously spent on this process.

Fire Prevention:

This year, as part of Council's fire prevention strategy, the Community Safety team initiated a public awareness campaign, specifically targeting properties that had previously received legal notices under section 105F of the Fire and Emergency Services Act over the last five years. The aim was to achieve higher rates of compliance at the beginning of the fire danger season in order to help keep our community safe from bushfire. As a result of this campaign, only 137 legal notices needed to be issued this season (to date), in comparison to 702 for the last fire danger season.

Moveable Signs: Over the past quarter only two complaints were received by the Community Safety team in relation to the placement of moveable signage. In each case, a conversation with the relevant business operator has led to the removal of any public safety risk without the need for Council enforcement.

Parking Management: Parking enforcement activities have led to the issuing of 61 parking expiations over this reporting period. Council's Community Safety and Infrastructure team's continue to work together to ensure that line marking and road traffic signage is compliant with Australian Standards, is simple for our community to understand and is legally enforceable.



Environmental Health

Deliver an effective and efficient operational environmental health service

The Environmental Health team continues to manage the immunisation, mosquito management and septic tank pump-out (Port Elliot and Goolwa) programs, and conduct routine inspections of premises under the Food Act and South Australian Public Health Act to ensure the safety of the public. Additionally, the team has focused on improving servicing of aerobic wastewater systems over the past two years. Anecdotally, this has resulted in a marked improvement in the understanding of owners over the past six months.

In an ongoing collaboration with operators from across the region, the site will continue to expand over coming months with updated images and information on tourism-related events, services, activities and accommodation.

In October, two Goolwa residents were heralded as Australia's oldest married couple, celebrating their 80th wedding anniversary with a cruise on the Paddle Steamer Oscar W. The happy event was captured by Network Ten's The Project and screened nationally.

This quarter our region hosted visitors from intrastate, interstate and overseas. The Goolwa Visitor Information Centre attracted 3,616 visitors, composed of 45% intrastate visitors, 42% interstate and 13% of visitors from overseas. The Strathalbyn Visitor Information Centre attracted 3,229 visitors; 56% intrastate visitors, 30% interstate and 14% from overseas, notably an increase in visitors from Asia.

Customer Services

Deliver excellence in customer service

During the October to December 2018 period, Council's Service Centre dealt with 11,661 phone calls. Almost 26,000 council payments to the value of \$10.9M were processed; 18% over the phone and in person, with the remaining 82% paid online. 80% of calls received to council were answered within 30 seconds, exceeding our target of 70% and the call abandonment rate was 2.72%. A total of 423 Property Search requests were processed to the value of \$21,253.05.

Service Centre targets achieved this quarter consisted of: average speed of answer - 19 seconds (target: within 30 sec); call abandonment rate - 2.72% (target: under 5%); average call handling time - 2.24 minutes (target: within 3 minutes); grade of service - 80% (target: 70% of calls answered within 30 seconds).

Over the Christmas/New Year period Council offices remained open, except for Public Holidays and Mondays 24 December and 31 December. During this period we received 170 phone calls. Thirty-eight customers visited the Goolwa office, and 25 visited Strathalbyn to access Council services. Customer enquiries and services included receiving resident's rate payments, animal registration enquiries, planning and building enquiries, waste services and accessing community information.



Develop and Implement an organisation wide Customer Service Strategy

Following the launch of Council's Customer Service Charter and Responsiveness Standards, internal Service Level Agreements are being established between Council departments to further promote the importance of a customer-centric culture at Alexandrina Council, and to agree on internal service levels.

Working collaboratively across Council to increase community awareness of facilities and services

Council staff attended both the Strathalbyn and Port Elliot shows in October. This year, we featured the theme of "Sustainable Spring" with tips and tricks on maintaining and creating sustainable gardens and verges, including giving away free seedlings, courtesy of Hindmarsh Island Landcare. In general, staff answered queries and promoted Council services, major projects, events, visitor information and the local government election. The children's badge-making activity was particularly popular.

Working in collaboration with our Communications and IT teams, the Service Centre supported a successful waste communication campaign with 843 residents with Exceptional Circumstances bins notified in advance of the change in service delivery during the summer period. As a result of the communication process, we experienced minimal customer enquiries relating to the disruption to this particular service.

Council continues to support our residents by selling composting products at a discounted rate and encouraging everyone to increase their recycling. Council also acts as a drop-off point for old mobile phones and batteries. During this quarter, 18 Compost Bins, 22 Worms Farms, 52 Kitchen Caddies and 79 replacement bag rolls were sold/supplied to residents. Six kilograms of old mobile phones and components were collected, and 80kg of batteries were deposited.

Event Management

Promote and support local Council funded festivals and events

Council supported the success of several community events this quarter. Highlights include Families Against Bullies @ Sails in Clayton Bay held in October, where approximately 300 people joined in the activities over the day, raising over \$1,000 for the Bully Zero Australia Foundation; and Cittaslow's Goolwa Smoke Off, held in November, which attracted over 1000 people. On New Year's Eve thousands of people watched the fireworks mounted on the Hindmarsh Island Bridge. In addition, four successful community Christmas events were held across the region, including Christmas Where The Angas Flows in Strathalbyn, Goolwa Christmas Festival and the Goolwa Lions Christmas Eve Children and Families Party and Carols in the Park, Port Elliot. Each received a funding contribution from Council. Additionally, Council administrative, transactional and promotional support was provided to community events and organisations including Huff n Puff Fun Run, Charity Bridge Swing, The Great Duck Race, Langhorne Creek Pop Up, Surf Live Saving SA, Surfing SA, Kiteboarding SA State Wave Titles, Milang Multisport Festival, Tour of Goolwa Cycling and the Rotary Australia Day BBQ.

Work with tourism event industry stakeholders and local tourism associations to boost the economy in the region

Alexandrina Council provides significant support to local tourism events, encouraging visitors to our region and providing them the opportunity to enjoy all the events and activities on offer. Tourism events this quarter included the Schoolies Festival held in Victor Harbor, attracting thousands to the Fleurieu, many of whom stayed in Port Elliot, Middleton and Goolwa in both commercial accommodation and private holiday homes. The 2018 Sporting Car Club's Classic Adelaide Rally travelled through our region with over 500 vehicles driving through the township of Strathalbyn.



Libraries

Manage library operations to deliver quality library services

During this quarter, two of the Alexandrina Library's 'special collections' have been very successful: 'Quick Reads' is a collection of the newest, most popular books that can be borrowed for ten days on the spot without reservation. The average turnover of each item in this collection is 14.84 (i.e. every item on average is borrowed over 14 times in a year), in comparison to the adult fiction turnover being 6.69 times per year; and, 'The Green Living' collection which was launched in September 2018 and has already seen 730 loans generated over the past three months.

Books by Colin Thiele, the author of Storm Boy, have been relabelled and launched as a specific 'Colin Thiele Collection'. Currently displayed near the entrance of the library, the re-launching of these classic books by a renowned South Australian author has promotoed a generation of new readers.

Public Library Services has conducted a review of the Library's Online Catalogue and have proposed a raft of changes to improve the catalogue, by featuring more intuitive, clear, user-friendly language for the customer. Changes to the user interface will be made over coming months.

Visits to the Goolwa and Strathalbyn libraries over this quarter were 1,190 and 464 respectively. Almost 1,000 items were borrowed and 90 customers utilised public computers. The Friends of the Goolwa Library book sale was also well attended with approximately \$500 being raised through the sale of old library books.

Deliver innovative library spaces that support the community to connect, collaborate and participate in diverse activities

The 'Tech Savvy Seniors' program at Goolwa and Strathalbyn libraries reached its conclusion in this quarter, with library staff having delivered 80 small group sessions for residents aged 60+ to learn about a diversity of technology-related topics, including 'How to use an iPad' and 'Online Shopping'. Additionally, the 'Be Connected' program supported 30 participants aged 65+ offering a one-on-one sessions with a library staff member to provide advice about technology and its use. Based on the success of these programs, we will again offer tech-friendly training for adults in 2019.

Provide Library services, programs and events for the Community that support life-long learning, literacy, recreational and cultural information

Alexandrina Libraries was a key partner in the Council-wide initiative "Sustainable Spring", a three month program of events from September through to November 2018 that brought together sustainability, the arts and practical do-it-yourself green living know-how to support and inspire members of the community to live more sustainably. This initiative is an example of a highly successful collaboration across numerous Council departments, including Alexandrina Libraries, Environmental Strategy, Parks and Gardens, Arts and Culture, Communications, Customer Service and Environmental Assets.

Community Wastewater Management Systems (CWMS) & Water Recycling

Provide effective and innovative community wastewater management

With \$60 million of wastewater assets across five regional towns within our Council, data has a significant impact on future regional planning. The CWMS team is developing a data strategy which will address technical gaps, emerging advances in the data and analytics disciplines and communications infrastructure across the network.

A series of breakages over the last couple of years has triggered the renewal of the Lakala pump station rising main in Port Elliot. This project is scheduled to be completed later in the financial year due with scoping and design specifications currently in development.

In a trend similar to last year, a total of nine rising main breakages occurred in the current reporting quarter. During this period the CWMS group also addressed a number of customer defect and Corrective Action requests with a 93% resolution rate. A total of 260 alarms have been received from critical infrastructure throughout the financial year reporting period which is slightly down from the same time last year (299). This included 131 occurring out-of-hours and requiring on-call personnel to attend.

Maximise the capacity & performance of our water recycling networks

Beneficial reuse of treated wastewater and stormwater has been higher in 2018/19 compared to the previous years. This is as a result of less rain over the winter and spring months, and the proactive management of storage capacities. A total of 14 ML of stormwater has been reused to date which is well above the historical averages (7.6 ML). 265 ML of treated wastewater has been beneficially used which is above the historical average but slightly lower than the same time last year.



Waste Management

Guide, Monitor and report on Regional Waste Authorities

With the new Goolwa waste and recycling depot now operational, this quarter attention turned to planning the complementary elements of the site, including upgrading the facility entrance and traffic management and reviewing lease arrangements for all onsite parties onsite.

A Public Place Recycling (PPR) trial is underway at the Goolwa Wharf as part of ongoing continuous improvement in waste services. The trial is a collaborative initiative that has brought together Council, the Fleurieu Regional Waste Authority, Cittaslow and Tidy Towns Goolwa. The trial will be monitored until after the completion of summer holiday period at which time a review by all parties will assess the success of PPR at the wharf, with particular emphasis on additional activities to improve recycling efforts.

Council is engaged in a proof of concept for Bin Bank management improvement. A newly developed design aims to reduce the impacts on rural communities due to uncontrolled litter, illegal dumping and unsolicited bin use. The new bin bank has been installed at a trial site in Hartley with some early feedback showing some flaws in the original design which can still allow third party access. Council will look to amend the design and seek customer feedback before considering at any future works.

Arts & Culture

Co-ordinate arts and cultural facilities, experiences and services

A total of 5 events were presented in Centenary Hall as part of the Just Add Water program of events:

- *A programmed school holiday activity 'The ScientifiBubble Show' featuring world bubble record- holder 'bubble- ologist' Marty McBubble, proved immensely popular with a sold out performance in front of 216 eager children and their families.
- *'Making Mozart the da Ponte Project' featuring the wonderful talents of members from SA's State Opera also was a popular event with 85% sales.
- *Annual favourites 'The Band of The SA Police' presented an afternoon of world class entertainment performing crowd favourites to a large audience (66%).
- *The local Wet Paint Youth Theatre Ensemble presented their annual performance and screening of short films to a rowdy and enthusiastic young audience
- *The final JAW performance for 2018 was '39 Forever' presented by popular television identity Amity Dry'. This one-woman show was a funny, poignant and thoroughly enjoyable evening for those in the surprisingly smaller than expected audience that attended.

Considerable time during the reporting period was committed to development of the 2019 JAW performing arts program and bringing the printed program to fruition. A total of 37 performances, workshops, events and activities have been secured for the 2019 Just Add Water Performing Arts Program to be presented in Centenary Hall and other venues across the Council region.

Embed arts and cultural programs in Alexandrina

An exhibition by two local artists Brenda Holden with David Hamilton yielded sales in excess of \$45,000. Genesis displayed a large body of work by Brenda Holden augmented by sculpture from David Hamilton both continuing favourite themes of Australian fauna.

The launch of the 2019 JAW program took place at Signal Point Gallery on December 15 to coincide with two mixed exhibitions on both levels of Signal Point Gallery. A crowd of approximately 150 people attended with speeches from Mayor Keith Parkes and CEO Glenn Rappensberg.

Support public art within the Alexandrina region

The Kenny Blake memorial sculpture, funded by the Community Grants round in 2017 was launched in November 2017 to great fanfare. A large number of people attended and heard speeches from the South Australian Governor Hieu Van Le and Mayor Keith Parkes.



Tourism

Promote, monitor and report on Council owned tourism services, facilities and activities

Income for PS Oscar W and the Goolwa Riverboat Centre for the December 2018 guarter:

- there was 1 private charter this quarter with a gross income of \$530
- Cruises \$10,341 (payment only taken at GRC on day of cruise).
- There were 10 public cruising days scheduled in the December 2018 guarter.
- Goolwa Riverboat Centre(GRC): 5,617 visitors through the door
- GRC Retail: \$5,228

Freelance journalist Tony Love travelled on PS Oscar W as research for a feature article he is writing for The Australian - 'Destination Afloat', showcasing Goolwa and the Coorong as a tourism destination. The article will be published in mid January 2019 to coincide with the release of the new Storm Boy movie in cinemas nationally on 17 January 2019.

In October 2018 Australia's oldest married couple, living in Goolwa, celebrated their 80th Wedding anniversary by travelling on the PS Oscar W. The couple were greeted by Mayor Keith Parkes before boarding the PS Oscar W for a 1 hour cruise around the lower Murray River. This event was captured by Channel 10's The Project and screened nationally.

Council's tourism services, facilities and activities were promoted during discussions with perspective event organisations including; Tour Down Under, Surf Life Saving SA, Goolwa Regatta Week and car club rallies.

The Events Coordinator provided general tourism information and links to Council's tourism website and accommodation guides to up and coming events.

Referrals were also made to up and coming events for Council's Festivals and Events funding and Community Donations programs.

The tourism website visitalexandrina.com was regularly updated with the latest event information. The monthly events listing Events Alexandrina was produced, edited and distributed via email and post to hundreds of businesses and accommodation, media and Visitor Information Centres. The publication features coming events, Alexandrina Visitor Information Centres and Galleries contact details, and the Fleurieu Heritage Experience and PS Oscar W cruise schedule. Council's tourism activities were also promoted on the Events Alexandrina Facebook page and various tourism and community publications.

Develop and implement an Alexandrina Tourism Plan

Staff are working with community groups to establish event plans and delivery of the SA Wooden Boat Festival (SAWBF), Tour Down Under Southaustralia.com stage 5 finish in Strathalbyn (TDU), the Summer & Spokes in Strathalbyn associated event and Storm Boy activities.

The SAWBF Committee now report directly to Council as a Section 41 Committee due to the abolishment of the Goolwa Wharf Precinct Board. The associated Memorandum of Understanding and Terms of Reference have been updated to reflect the changes. Monthly meetings continue with communication links between the community committee and council staff being well established. These links help with the support required for compliance, WHS and operational procedures.

The advertising and marketing strategy has been activated with press releases, adverts, printed material and editorials in various media including Fleurieu Living, SA Life, Caravanning Australia Magazines and the Alexandrina Council newsletter.

The official launch date for the SAWBF is February 13 in Signal Point at 5pm. There will be a Mayoral Reception and Boatie BBQ on Friday night 26 April and fireworks on Saturday night.

Council Officers have established a working group to ensure logistical, technical and operational aspects support and compliment the TDU, Events SA major event. Communications/Marketing, Risk Management,



Community Engagement, Town Beautification and Volunteer Management are complete and the required ones sent to TDU Events SA.

A Community Committee has been formed by the Strathalbyn Tourism Association and is being supported by the Tourism Coordinator to plan the supporting community event Summer & Spokes in Strathalbyn.

The Tourism Coordinator and General Manager Growth are members of the Storm Boy working party which includes staff from Spirit Australia, Department of Environment and Water, Fleurieu Peninsula Tourism and Murray River, Lakes and Coorong Tourism Officers. A communications plan has been developed by this group and they have been working together to set up ongoing strategies to communicate to the general public not only about the new Storm Boy film but also to implement communication strategies to protect the fragile Coorong environment. This includes increasing signage, care for board walks and actively involving local business and community to help promote these messages and raise awareness. Through this group Sony sent out a Study guide for schools. The Tourism Coordinator has sent this guide to all Primary and Secondary schools in the Alexandrina Council region.

Storm Boy has been extensively advertised and promoted through the South Australian Tourism Commission, Fleurieu Peninsula Tourism, including blogs on websites, social media posts and a SATC Storm Boy inspired itinerary plus various articles in print media including an editorial in Tiger Tales inflight magazine on Tiger Air. All of this marketing and promotion provided by others leads people to our region the heart of Storm Boy Country which gives local businesses and the Tourism team great opportunities to leverage off the promotion.

Development Assessment - Building

Undertake building rules assessment of development applications in accordance with the Development Act & Regulations and Building Code of Australia

Provide an active & effective Building Fire Safety Committee

For the period 3 premises were inspected, with all 3 of those being inspected by the full Committee.

Progress on fire safety upgrades is monitored closely.

Provide Building Rules advice and assessment

Councils building section has issued consents for 106 building rules applications out of a total of 212 building consents granted in the Council area for the period (including private certification). This equates to 52% of all building consents being assessed by Council building surveyors.

The 212 consents included 72 new dwellings and 19 dwelling additions.

The total number of building rules consents issued was up by 1% when compared with the same period last year. The development approvals for this period also involved a lower percentage of dwellings and dwelling additions (20%) when compared with minor class 10 structures (verandah/carport/garage etc.) .The number of new dwellings approved was up by 100% and dwelling additions approved was up by 25% when compared to the same period last year.

Report on inspections (Buildings & Swimming Pools) and enforcement activities

For the period a total of 77 inspections were carried out, including 65 structural frames and 12 swimming pools. The requirements of the building & swimming pool inspection policy have been satisfied.

In addition to the statutory inspections, audit inspections of older swimming pools are being carried out when time permits, with 1 being inspected for the period.

The Council Assessment Panel met on 3 occasions and has issued 8 approvals, 1 refusal and considered and allowed 2 resolve to proceed applications.

One appeal was lodged during the reporting period.

The Council determined to proceed with the preparation of a Statement of Intent regarding the potential rezoning of the Strathalbyn Deferred Urban Zones at its December meeting.

Minor Project Reporting

World Heritage Bid (MinP)

Status Update: There have been no project management or steering group meetings during the reporting period. A report was prepared for the September Council meeting following a workshop to seek Council's position on its future involvement with the project.
