Chief Executive Officer's - Quarterly Update

October to December 2017

I am pleased to report that Council's major business outcomes remain on track and importantly on budget as we commence 2018.

In particular, the October to December 2017 quarter has seen the completion of a number of significant Infrastructure projects. Construction of the Strathalbyn Woodshed building and sealing the full length of Nile Mile Road are now complete and ready for community use. Delivery of the new Soldiers Memorial Gardens Strathalbyn Public Toilet is also complete.

Over the October holiday period, 231 children attended Council's School Holiday Program with half attending at Goolwa and the other half at Strathalbyn seeing performances such as Mickster the Trickster.

The annual Regional Youth Art show at Signal Point Gallery saw the strongest and most coordinated response from teachers and students across the Fleurieu, with significant support from Victor Harbor High School, Investigator College and the Department for Education and Child Development's Flexible Learning Options programs.

On 24 November, Alexandrina Council thanked volunteers for their hard work and tireless commitment in supporting Council in its provision of services to the community. Alexandrina Council has over 450 registered volunteers, who have so far this year, contributed nearly 41,000 hours of assistance, equating to a value of over \$1,120,000. Volunteers present on the day enjoyed

a light lunch, friendly camaraderie and beautiful weather, basking in the satisfaction of providing vital support to our fantastic community here in Alexandrina.

The summer months also saw Council's corporate Facebook pages continue to grow with over 2,600 likes. Furthermore, our engagement levels for posts far exceed our 'likes'. We also continue to post rich content, as every post is accompanied by a colourful image.

The highly anticipated release of the 2018 Just Add Water (JAW) Alexandrina Arts and Culture Program took place with an official launch in December at Signal Point Gallery, Goolwa. The seventh instalment of the 2018 JAW program presents shows in all major towns of the district including Goolwa, Mount Compass, Port Elliot, Langhorne Creek and Strathalbyn and will spark the interest of all age groups and backgrounds.

Finally, the Strath Neighbourhood Centre was successful in attaining a \$150,000 grant through the State Government's Fund My Neighbourhood Program supported by the Alexandrina Council. This will add to Council's already allocated funds of \$120,000 to improve and renovate the Strathalbyn Senior Citizens building. These renovations will enable the relocation of the Strath Neighbourhood Centre to the Senior Citizens building and encourage intergenerational community collaboration.

We look forward to continuing to present highlights to Council and community throughout the coming year!

In early October, Mayor Parkes and Mr Rappensberg attended the 2017 Port Elliot Show and the opening of the Goolwa Regatta Yacht Club Season.

Mayor Parkes acknowledged the contribution of Council's volunteers at the annual recognition event.

Mayor Parkes and Mr Rappensberg toured the Clayton Bay Community Nursery and attended the opening of the Wildlife Welfare Centre in Goolwa.

The inaugural Alexandrina Business Life Breakfast was hosted by Mr Rappensberg on 25 October, which was attended by 40 local business operators.

The official opening of the new Strathalbyn Football Club facility took place on 12 November.

Mayor Parkes and Mr Rappensberg attended end of year school presentation nights at Goolwa, Strathalbyn and Victor Harbor.

The 2018 Just Add Water program was launched by Mayor Parkes on 9 December.

Mayor Parkes undertook regular interviews with Fleurieu FM and Radio 5MU.

Community group meetings attended by the Mayor included Goolwa Surf Life Saving Building Committee, Goolwa Neighbourhood Watch, Clayton Bay Community Nursery, the Strathalbyn Neighbourhood Centre Annual general meeting(AGM), Goolwa RSL AGM, Goolwa Cittaslow and the Strathalbyn Community Action Planning group.

Mr Rappensberg attended a meeting of the Port Elliot Town and Foreshore Group, and was guest speaker at a meeting of the Goolwa Rotary Club.

Organisational leadership to drive achievement of local and regional outcomes

During this quarter, Mayor Parkes and Mr Rappensberg travelled to Murray Bridge to attend a SA Murray River Alliance meeting; and with other regional Mayors and CEOs, a Regional Collaboration Opportunities Meeting.

The Lower Lakes and Coorong Boating and Tourism Group held their first meeting at Council, which was attended by Mayor Parkes and Mr Rappensberg.

On 10 November, Mayor Parkes and Mr Rappensberg hosted a visit to Council by Senator Cory Bernardi,





Leader of the Australian Conservatives Party and The Hon Robert Brokenshire MLC.

In November, Mayor Parkes and Mr Rappensberg attended the LGA Annual General Meeting in Adelaide, which addressed rate capping and future proofing Councils.

The historically significant Native Title Consent Determination took place at Murray Bridge on 14 December, which was attended by State Government dignitaries, together with Mayor Parkes, Elected Members and Mr Rappensberg. The court formally consented to native title and Council received the official data for its records.

Mayor Parkes and Mr Rappensberg attended the Strathalbyn Development Plan Amendment (DPA), Shop Front on several occasions, in relation to the Strathalbyn DPA, following the consultation process which commenced on 16 November.

At the invitation of the Terramin Angas Zinc Mine, Mayor Parkes and Mr Rappensberg met the Strathalbyn Community Consultative Committee and enjoyed a tour of the facility.

During this time, Mayor Parkes attended the SA Regional Organisation of Councils and Local Government Association (LGA) Board Meetings in Adelaide and Port Pirie and with Mr Rappensberg, attended meetings of the Southern and Hills LGA, the Economic Development Advisory Panel and the Goolwa Wharf Precinct Board.

Community Safety

Deliver an effective and efficient operational community safety service

Animal Management:

The number of dogs registered for this financial year is up to 6899. Approximately 256 new dogs have been registered. At the end of this reporting period, only 13 outstanding dog registrations remain from 2017/18 which officers continue to follow up. This is the lowest number of outstanding registrations Council has had and is a result of altered practices and utilising SMS technology. This has significantly increased the efficiency of the process for following up failure to renew dog registrations.

In this reporting period there were a total of 26 dogs impounded. Twelve were returned directly to their owners and 11 to their owners via the pound. Two dogs were transferred to a rehoming project as the owners were unable to be located and one dog was euthanised due to its poor health and condition.

Over this reporting period, 5 feral cats and 1 domesticated cat were trapped- the domestic cat was claimed by the person who trapped the cat.

During this reporting period the Draft Animal Management plan was endorsed by the Dog and Cat Management Board and will be effective as of 1 January 2018.

Changes to the Dog and Cat Management Act came into effect on 1 July and as a result, dog registration categories have now been updated.

Fire Prevention:

All major assets have now been identified and appropriate treatments have been allocated. This will impact on block inspections once the new Fleurieu Bush Fire Management Plan is adopted. The Bushfire Management Plan was approved by the State Co-ordinating Committee on 13 December 2017.

Roadside slashing commenced in this reporting period. At the time of preparing this report the slashing had not been completed due to weather conditions. It is anticipated to be completed in January 2018.

Block inspections were undertaken during this quarter. As a result, approximately 669 properties were issued with legal notices to ensure fire safety requirements are met (105F notices).

General Compliance:

There have been 7 reports of abandoned vehicles for this quarter, all of which were removed by their





owners at the request of Council.

There have been 33 reports of illegally dumped rubbish reported to the Community Safety team over this reporting period.

There were 2 customer concerns lodged with our team in relation moveable signs this reporting period. The new Signs Policy has been endorsed by Council. Over the next reporting period it is planned to provide businesses with education/information as the first phase of implementing the new Signage requirements. Until the roll out of the implementation plan is complete all moveable sign complaints continue to be dealt with on a complaint by complaint basis. Safety is the only aspect being assessed to address these complaints.

The Nuisance aspect of the Local Nuisance and Litter Control Act came into effect on 1 July 2017. One main issue facing our officers as a result of this continues to be the absence of training and supporting materials provided by the State as part of the transfer of these responsibilities to Local Government.

Parking Management:

Officers are undertaking parking patrols as part of their everyday duties as resources permit. Officers responded to 17 parking related complaints over the quarter. In total 10 parking expiations were issued over the quarter. School zones continue to be patrolled as part of day to day duties.





Enviroment Health

Deliver an effective and efficient operational environmental health service

Council continues to engage Veolia Environmental Services to manage the septic tank pump out program for all septic tanks connected to Council common effluent system. In preparation for current contract expiry in 2017/18 the current contract has been reviewed and a new Request for Tender (RFT) has been released. Tenders for this will be evaluated in the upcoming quarter with a new contract envisaged to be entered into in February 2018.

The Environmental Health team are continuing to work with the Sustainable Resources team to review the process and identify the most effective and efficient method of managing desludging both private tanks connected to Septic Tank Effluent Disposal Scheme (STEDS) and Council infrastructure.

For this period 83 waste water works application assessments and 41 plumbing inspections were undertaken by the Environmental Health team. Of these, 9 were inspections of previously approved systems to ensure correct installation as the prior inspection had highlighted installation concerns. During this period, 109 non-compliant aerobic servicing reports were received, with 10% of these followed up in accordance with procedure. 52 compliant aerobic servicing reports were also followed up to ensure accuracy of reports. In addition to this, 5 notification of failure to service were received and followed up and 5 complaints in relation to failing wastewater systems. As a result of these and other ongoing complaints, 27 legal notices were issued requiring action by the customer.

Council continues to undertake routine inspections of swimming pools and skin penetration premises within the Council areas and respond to community concerns when required. During the last quarter, 4 of the public swimming pools have been inspected. No complaints associated with these businesses were received.

Over the last quarter Council's Environmental Health team have continued to follow up on self-audit reports from hairdresser and skin penetration businesses and have conducted 3 follow up inspections.

Over the past quarter the Environmental Health team have undertaken 56 food business inspections. Also during this period there were 4 food recall complaints that required follow up, and these were followed up with relevant businesses. Two complaints in relation to unsafe food were received and investigated during the past quarter. 'I'm ALERT', an online food safety training program offered through the Council website for food handlers reached a milestone of 400 users during the past quarter.

As the legislative requirement, Council continues to maintain a High Risk Manufactured Water System (HRMWS) register and ensure all audits of these systems are undertaken as required. In the past quarter, 2 of the HRMWS located in the Council area have been due for their audits- one has been fully completed and Council staff are working with the other premises to ensure legislative compliance is reached.

Council continues to engage the services of the City of Onkaparinga to deliver immunisation services to our community. In addition to the school clinics, monthly community clinics are held in both Goolwa and Strathalbyn.

During the last quarter, the Meningococcal B vaccination study has continued and the contract with City of Onkaparinga has been extended for a further 12 months.





Environmental Strategy

Environmental Action Plan 2014-2018

As of the end of the quarter, progress has been made against:

- -95% of ongoing actions,
- -81% of short-term actions.
- -63% of medium-term actions and
- -8% of long-term actions.

Implementation priorities for the remaining 18-month life of Environmental Action Plan have been determined with a focus on reducing Council's corporate footprint, climate adaptation and internal process improvements for the protection of biodiversity.

The Environmental Action Plan is due for review in the third guarter of 2018.

Develop and implement progressive approach to climate change

The Resilient Hills & Coast Steering Committee met in October 2017 and the Regional Coordinator presented at the "Prosperity in a Changing Climate" symposium hosted by Climate Services Australia in November 2017. Resilient Hills & Coast Councils released a Request for Proposal in December 2017 for the delivery of a region-wide Community Energy Program which will empower local residents and businesses to reduce their energy costs via the uptake of renewable energy and storage. With assistance from the Regional Coordinator, Alexandrina Council is tendering for Coastal Adaptation Strategies which will assess erosion and inundation risk to 2050 and 2100.

Council is continuing to advocate for an Intergovernmental Taskforce on the Future of the Barrages to assess and plan for the impacts of climate change on the Coorong, Lower Lakes and Murray Mouth region.

Energy and carbon inventories for 2012-2016 have been finalised subject to final review of data integrity. Automatic capture of quarterly energy data is ongoing. Planning has commenced for an energy audit of the Goolwa Administration Building which will be used to develop a business case for future energy efficiency improvements.

Develop and deliver program for protection of water resources

Reporting for 2016/17 was completed in this quarter. In 2016/17 total water use increased by 6ML to 125ML in comparison to 2015/16. Annual mains water use is now 65ML, up 26ML from a low of 39ML in 2010/11 but still 12ML lower than our high of 77ML in 2006/2007. Council use of recycled waste and storm water increased by 2ML to 37ML as compared to 2015/16.

All new or upgraded facilities are afforded water saving technologies.

Council continues to monitor political developments with respect to implementation of the Murray-Darling Basin (MDBA) Plan and pursue advocacy opportunities as appropriate. In November 2017, Cr Barry Featherston was re-elected as Chair of Murray Darling Association (MDA) Region 6 and recruitment for a part-time MDA Region 6 Executive Officer commenced. This is a jointly funded position with Coorong District Council and Rural City of Murray Bridge. The Murray Darling Association is the peak body representing local government with respect to Murray Darling Basin water resource management issues at a state and federal level. A MDA Region 6 strategic planning workshop held in November 2017 has set the agenda for regional advocacy priorities in 2018.





Improve management of Council's environmental assets

In 2017/18, Council's Biodiversity Team actively manages 136.43h of reserve and 139km of roadsides for the benefit of nature conservation. Plans/policies/projects currently underway include:

- -Ratalang Basham Beach Conservation Reserve Master Plan
- -Tree Management Policy and Procedure
- -Improvements to our Roadside Marker System

Council also undertook a review of the Clayton Bay Foreshore Masterplan and endorsed minor amendments to address public safety and amenity concerns whilst maintaining urban biodiversity values.

In 2017/18 Council's third-party conservation partners are actively managing 229.48 ha of reserve and 51km of roadside for the benefit of nature conservation.

Other activities undertaken in partnership with community in this quarter include:

- -The second meeting of the Environmental Advisory Panel at which a 2-year work-plan was adopted.
- -Completion of design work for the upcoming Gazania Free Goolwa campaign ready for launch in early 2018.

Gazania Free Goolwa is an urban biodiversity education campaign being delivered in partnership with Goolwa to Wellington Local Action Planning Association (GWLAP), Goolwa Coastcare and Alexandrina Nursery.

Environmental staff continue to collaborate across Council to maximise and promote environmental outcomes. Projects underway in this quarter include:

- -work with Community Wellbeing, Parks & Gardens and the Middleton Town & Foreshore Committee to plant a public orchard of citrus trees in Abbots Reserve.
- -The outcomes of the Goolwa public place recycling trial delivered in collaboration with Fleurieu Regional Waste Authority (FRWA) and Goolwa Surf Life Saving Club in 2017 have been reviewed and discussions around the potential for a further trial.
- -Stage 1 of interpretive signage for the Clayton Bay Foreshore has been installed in collaboration with Recreational Services.

Provide effective and innovative community wastewater management

Capital Renewal/Upgrade of Community Wastewater Management System (CWMS) Infrastructure-

Unscheduled works relating to Department of Health process upgrades at the Mount Compass wastewater treatment plant are continuing as a priority.

Contracted works have been developed to undertake improvements in gravity network defects and access issues across targeted schemes. This will provide an accurate assessment of the total current liability from defects in the Goolwa and Port Elliot networks.

Condition assessments have been completed for access points, manholes and pump chambers for developing a prioritisation plan for the asset rehabilitations. This project has been parked due to major project commitments. It is still anticipated that this will occur in financial year 17-18.

CWMS crane and gantry at Goolwa North Vacuum Station- The project is a risk and WHS priority for ensuring access, maintenance and service capability to the large vacuum station pumps that control the entire system. Contracts have now been signed and works are predicted to start and end in March of this year.

CWMS continuous improvement initiatives-

Through consultation with SA Water and TAFE SA we have initiated formalised training for our CWMS operators in Certificate III Wastewater Operations.





Develop wastewater network process monitoring system

The roll out of sensory upgrades continues across the network to improve data acquisition and control systems. This includes more reliable battery backup and monitoring capability to reducing public and business risk.

Supervisory Control and Data Acquisition (SCADA) and process monitoring project has been endorsed by the Chief Executive Officer and we have been granted approval to start recruitment for a suitable temporary Project Officer to implement a strategic solution. Implementation of process monitoring solution is a major strategic step for the long-term reliability and optimisation of the water industry.

Following the 2016 winter period, detailed analysis was undertaken during October and November 2016 to assess the impact of storm damage. Substantial asset damage was incurred across Council's District, with particular impact experienced with road and storm water assets including major bridges, major culverts and minor storm water assets.

GHD Consulting, in conjunction with Council's Infrastructure & Engineering staff undertook extensive assessment, cost analysis, funding discussion and works scheduling as we look to repair and/or replace affected assets. Critically, this substantial commitment has resulted in Council being advised of a successful funding partnership with the State Government, on an approximate 50% cost share basis. In conjunction with the funding partner, all storm damaged assets have now been either repaired (25% of damaged assets (road) completed) or scheduled for design and construction within pending 18 month period. This professional commitment has placed (and will continue to place) large resource pressure upon Infrastructure and Engineering staff as funding authority milestones are required to be met and reported against, with all works required for completion by the end of June 2019.

Storm damage packages have been prepared, Request for Tender processes undertaken or in progress - with substantial on ground works and project management to follow.

A Portion of storm damage on-ground works are now being managed by infrastructure staff to ensure milestones are achieved.

Building & Property Management

Delivery of capital & renewal building projects in accordance with adopted Long Term Financial Plan & Annual Business Plan

Notable building projects undertaken in second quarter include:

- Commercial Road public toilet renewal
- Old Corporation Building refurbishment works have commenced. Strathalbyn Community Arts and Crafts group have been willingly relocated to the Council's High Street office to provide enhanced community outcomes. The Old Corporation Building is now being refitted to afford additional Council administration options. Works scheduled for completion end February 2018.
- Goolwa Wharf structural assessment now complete via Wallbridge Gilbert Aztec Engineers, with finalised report providing firm recommendation and direction on priority based approach to Wharf structural renewal. Wharf structural works now deferred, subject to Building Better Regions Funding.
- Strathalbyn Town Hall and Strathalbyn Senior Citizens Hall internal refurbishment design works commencing. Scope preparation and internal design phases are currently underway and will be presented to Council for approval in the third quarter.
- Building Condition Rating Project has commenced, with MYKRA Building Services and Council's Building Coordinator undertaking this large project within following nine month period.





Management of Council owned buildings and facilities, property lease agreements

Progressing in accordance with requirements.

Substantial and ongoing efforts continue within the property portfolio - with a large number of Council driven objectives being managed by Property Officer. All matters require substantial and sustained attention, with notable lease & property matters including:

- RSL Goolwa Sub-Branch building negotiations and future tenure options
- Alongshore Properties No 1 Pty Ltd (Alongshore marina), future tenure options and opportunities following 1 April 2018
- Goolwa Boat Haven lease determination and future lease holder opportunity

- Signal Point, future lease options and opportunities within building space
- Goolwa Sports Stadium, daily operational, maintenance and management matters now absorbed via the Infrastructure team

Improved offsite scanning service

The Information Management team undertook procurement for new offsite storage, scanning and secure destruction service through the Local Government Information Technology South Australia Panel Contract. The new service resulted in the transfer of approximately 38227 files to a new authorised storage provider for offsite storage.

The new provider is providing a more efficient scan on demand service with requests finalised in hours rather than days, and is also expected to provide cost savings. The transfer of secure destruction to a new service provider has also been completed.

Undertake building rules assessment of development applications in accordance with the Development Act & Regulations and Building Code of Australia

Building Inspections

For the period a total of 70 inspections were carried out, including 57 structural frames (includes 11 follow up inspections) and 9 swimming pools (includes 1 follow up inspections).

The requirements of the building & swimming pool inspection policy have been satisfied.

Building Fire Safety Committee

For the period, 6 premises were inspected with 3 of those being inspected by the full Committee.

Progress on fire safety upgrades is monitored closely.

The next meeting is 27 April 2018.

Building Rules Advice and Assessment

Council's building section has issued consents for 127 building rules applications out of a total of 210 building consents granted in the Council area for the period (including private certification). This equates to 60% of all building consents being assessed by Council building surveyors.

The consents included 36 new dwellings and 15 dwelling additions.

The total number of building rules consents issued was down by 16% when compared with the same period last year. The development approvals for this period also involved a higher percentage of minor class 10 buildings (verandah/carport/garage etc.) when compared to the number of new dwellings and dwelling additions. The number of new dwellings approved was down by 25% and dwelling additions approved was down by 28% when compared to the same period last year.





Development Assessment - Planning

Undertake planning assessment of development applications in accordance with the Development, Act & Regulations

During the reporting period, 200 planning consents were issued with the median number of days for a merit (Category 1 application) to be approved being 10 days.

The new Council Assessment Panel has met on three occasions and adopted its meeting procedures requesting that Council appoint a Deputy Member to ensure that if maintains a quorum should members not are able to attend. It was decided that as there are only 5 members there would be more chance of this occurring. A report was presented to the 18 December 2017 Council meeting where it was resolved to undertake an Expression of Interest process to appoint an independent member and that a deputy elected member also be appointed at the same time. This process will be undertaken during February 2018.

During the period no appeals were lodged with the Environment, Resources and Development Court.

Provide sustainable growth of townships and rural areas through progressive and appropriate policy planning

Strathalbyn Township and Environs Development Plan Amendment (DPA) - Update

The following has occurred during the reporting period:

- Ministerial approval to proceed to consultation was received in October and after making some amendments to the DPA, following directions from the Minister. Community consultation commenced on 16 November 2017. The consultation period will run for 9 weeks with all information being available on Council's website and staff being present one day a week at Shop 4 Dawson Street, Strathalbyn to answer questions with respect to the DPA. To date these have been very successful with the final session being on 18 January 2018 just prior to the conclusion of the consultation period on 19 January 2018. A public hearing will then be held on 17 February 2018 to hear those who have requested to be heard on their formal submission.
- Strathalbyn District Centre Traffic, Car Parking and Streetscape Plan Council adopted the staging plan at its 16 October 2017 meeting as well as approving the seeking of external funding opportunities to assist with the implementation of the plan. As a result an application was submitted for Places for People funding with the Department of Planning, Transport and Infrastructure for Stage 1 of the project which was submitted at the end of October. Council is yet to be informed of whether this has been successful.

Goolwa Growth Area - Update

No further progress has occurred during the reporting period with respect to this project. With the progression of the transition process to the Planning, Development and Infrastructure Act commencing it is expected that this will progress in early 2018.

Planning, Development and Infrastructure Act - Update

During the reporting period the following has occurred:

- Community Engagement Charter formal consultation was undertaken and completed in early December 2017. It is expected to be released in February 2018.
- Planning and Design Code with the endorsement of the Code framework by the Commission





appointments with the Department of Planning, Transport and Infrastructure (DPTI) Transition Managers occurred with Council planning staff in October and December. A Collaborative Work Program is being established to assist Council with the processes required to transition to the new Code. Theme papers are also being prepared that will assist in informing the Code content and it is expected that consultation on these will occur in the first half of 2018.

Minor Project Reporting

World Heritage Bid

Status Update: During the reporting period three project management group meetings have been held.

Very successful workshops were held in October and November which has further strengthened the support for the project. The Aboriginal workshop held in October resulted in a Statement of Support being prepared that was subsequently signed in November by the three key Kaurna groups. The workshops held in November to coincide with the International Council on Monuments and Sites (ICOMOS) meeting were also very successful with assisting in refining the bid at both the national and world level and to identify other key research that may be required.

Currently Council is awaiting a response from the Chair of the Project Steering Group to its request for further investigations to occur to include the Langhorne Creek area within the bid boundary. Until a position is known Council is withholding any financial support for the project but is continuing as a collaborative partner.

The annual Regional Youth Art show in November at Signal Point Gallery saw the strongest and most coordinated response from teachers and their students across the Fleurieu with particularly high support from Victor Harbor High School, Investigator College and the Flexible Learning Options (FLO) programs from Victor Harbor.

The Just Add Water program for 2018 was launched on December 10 along with the two exhibition openings within the Signal Point Gallery; a Country Arts SA touring exhibition and a local sculpture exhibition.

Visitation across Signal Point Gallery and South Coast Regional Art Centre for the quarter was 4,961.

There has been increased activity with events within the Goolwa Wharf Precinct. The Poetry Cup event in November attracted young poets in partnership with the Fleurieu Distillery.

At The Wharf events on the Deck at Signal Point organised by Cittaslow food and wine group have become increasingly popular and events were held in October, November, and December. The December event attracted large crowds and food vendors reporting excellent sales.

Coordination of Centenary Hall and delivery of arts and cultural activities across the region as part of the JAW program-Centenary Hall has hosted a total of 43 activities during the October - December reporting period. Activities included: Five (5) Just Add Water (JAW) performances, one (1) Commercial Hire and a Council General Staff Meeting. Centenary Hall has also been utilised for thirty - six (36) individual community activities including monthly screenings by the Southern Fleurieu Film Society, regular rehearsals by the Goolwa Concert Band and the Wet Paint Youth Theatre rehearsals and end of year performances. A significant proportion of coordination time during this period has been spent on development or the 2018 Just Add Water program. This involved extensive consultation and coordination with commercial promoters, event management agencies, artists, and prospective collaborative venue coordinators across the Council district.

Co-ordinate arts and cultural facilities, and experiences and services across the region as part of the JAW program- This action is in progress with a high level of Arts and Cultural activity becoming a way of life for residents and visitors to the Alexandrina region. Strathalbyn Woodshed

The new woodshed is technically complete and the certificate of occupancy has been issued. The Woodshed committee have relocated all equipment from the old woodshed. Landscaping at the new site will commence in February with tree planting in March. Council contributed \$305,000 and oversaw the construction of this project to deliver an improved fit for purpose community space.

Fund My Neighbourhood Grant

The Strath Neighbourhood Centre's Community Development Officer in conjunction with the Strathalbyn Senior Citizens group, supported by the Alexandrina Council's Community Development Officer was successful in their bid for a Fund my Neighbourhood State Government Grant of \$150,000. This will add to Council's already allocated funds of \$120,000 to improve and renovate the Strathalbyn Senior Citizens building. These renovations will enable the relocation of the Strath Neighbourhood Centre to the Senior Citizens building and encourage community collaboration.

The Dementia Caddy Program Funding

The Dementia Caddy program pilot was successful in receiving funding of \$26,000 from the Office for Ageing to roll out the project in 2018. This project aims to develop volunteers to accompany and assist people with dementia while they do activities such as shopping, social outings or recreation. The project was also supported by Alzheimer's Australia and Research Fellow, Monica Cations from Flinders University.

Community Wellbeing Events

A very successful program of events were held for Mental Health week. The program included a youth well-being expo 'Let's go Mental for Mental Health Week' with various other mental health and Wellbeing workshops and activities for all age demographics.

The 3rd Goolwa White Ribbon Day Breakfast, held on Wednesday 28 November 2017, was well attended with over 90 white ribbons being given away. Alexandrina Council along with Junction Australia and the Goolwa Children's Centre jointly support this event financially and in-kind.

During the October to December 2017, the Customer Service Centre received 11,747 phone calls. Approximately 25,000 council payments were processed, 27% being either over the phone or in person and the remaining 73% paid via online means.

73% of calls received to council were answered within 30 seconds, exceeding our target of 70%. 62% of these calls were resolved at the first point of contact.

436 Property Search requests were processed, consistent with the same period in 2016.

Customer Service Initatives

Council attended both the 2017 Strathalbyn Show on Monday October 2 and Port Elliot Show on Saturday 7 and Sunday 8 October in the form of an Information Marquee. Fleurieu Regional Waste Authority (FRWA)'s Education Officer joined us at the Port Elliot Show to promote the benefits of recycling and composting along with being on hand to answer any waste related enquiries. Council was presented with a certificate for the "Best Dressed Stall 2017" at the Port Elliot Show.

The Customer Service Centre continues to provide valuable support to our residents as they embrace Council's fortnightly kerbside waste collection. The Service Centre supported the successful communication process to 813 residents with Exceptional Circumstances (EC) bins by notifying them via SMS messages, email and phone calls of the change in service delivery of their EC bins during the summer period. As a result of the successful communication process we experienced minimal customer enquiries relating to the short term changes to this particular service.

Funds raised by the Friends of Strathalbyn Library were utilised to purchase a new dishwasher for the Strathalbyn Community Centre and a hot and cold water unit for the Community Kitchen at the Strathalbyn Library.

Alexandrina Libraries Events & Services

On Tuesday 24 October at the Strathalbyn Library Community Centre, 86 people attended two decluttering workshops presented by Adelaide's most experienced and accredited professional organiser Rebecca Mezzino. Very positive feedback was received from participants.

The Goolwa Library was transformed into an 'Acoustic Lounge' for a special music event on Saturday 18 November featuring 3 live performances. The event was badged as family friendly and included Stop n Go 'pedal power' smoothies, face painting, fresh fruit fusions and give away fruit. 60 people attended.

231 children attended the October School Holiday Program. Half of these participants attended 4 events at Goolwa Library including craft sessions, Garageband iPad workshop and a performance by Mickster the Trickster. Strathalbyn Library had the other half with 4 events including craft sessions and Kitchen chemistry presented by Mobile Science Education and performances also by Mickster the Trickster.

Baby Bounce & rhyme, Storytelling & Craft attendees were 137 at Goolwa and 130 at Strathalbyn for the quarter.

Eastern Fleurieu School had a Year 4 tour at Strathalbyn Library during November and the class learned about the different aspects of the library service and enjoyed asking questions.

46 active volunteers provided 1,355 volunteer hours during the last quarter. These volunteers assist in providing quality library service.

Friends of Goolwa Library had their Annual General Meeting on 4 October with 23 people in attendance. The speaker for the day was Dirk Nieuwenhoven who spoke about "Cadell's Dream" and centred around the life of Francis Cadell, the building of the first railway in Australia, and the stabling of the horses on the present site of the Goolwa RSL Building.

Public Library Services (PLS) have loaned us a mini-maker space that contains a 3D Printer, flying drone and 3D Doodler pens. These will be incorporated into library programs and are available for use from January.

The introduction of Facebook to the methods in which Alexandrina Libraries can now promote its services will allow for greater reach and involvement.

The 2018 Just Add Water Arts and Culture program was launched on Saturday 9 December at.2.30pm in Signal Point.

Since the launch of the 2018 program, Alexandrina Visitor Services staff have processed 365 ticket sales with a gross value of \$12,317. The most popular show to date has been the two Adelaide Symphony Orchestra performances on Saturday 27 January, in Centenary Hall.

- -368 Tickets sold in December for the 2018 programed events at a gross value of \$12,426 this is a 49% increase on the December 2016 ticket sales for the 2017 Just Add Water program.





Event Management

Promote and support local Council funded festivals and events

Liaise with Council funded event organisers and support the Festivals and Events Funding Program -This action is in progress and endorsement of Council's support for events grants was received at the Monday 4 November 2017 Council meeting.

Council's support will include cash and/or in-kind for the twelve events and four Christmas events during the 2017/18 financial year.

Presentation of Certificates of support for Council Community Donations program took place prior to the Council meeting held on Monday 4 December 2017.

Two Council funded events took place during this quarter and the following information is from verbal reports from the event organisers:

Smoke Off - Goolwa November 2017

Approximately 1000 people attended, the weather was ideal and the presence of Langhorne Creek Wineries again successful.

Fireworks Off The Bridge - Goolwa December 2017

On New Year's Eve thousands of people watched the fireworks that were set off on Hindmarsh Island Bridge, from their boats, within the Goolwa Wharf Precinct and along the river.

Four Christmas events took place during December and the following information is from verbal reports from the event organisers:

Christmas Where The Angas Flows - Strathalbyn

The community lined the streets of Strathalbyn for the pageant. Over 1,500 people attended the carols and fireworks in the Soldiers Memorial Gardens and enjoyed the rides and activities during the evening.

Goolwa Christmas Festival - Goolwa

Thousands attended the Goolwa Pageant and Christmas Carols, Santa was very popular with the children and the fireworks were well received. The pageant route travels past Sandpiper Lodge so they can be involved and enjoy the celebrations, this continues to be appreciated and enjoyed by the residents. The Christmas Festival had outgrown the Arthur Neighbour Reserve and relocated to the Goolwa Oval. The move to the oval proved to be a great success providing a larger and safer environment for those who attended.

Port Elliot Carols - Port Elliot

The Port Elliot community delighted in an evening of Christmas Carols and a visit from Santa in the Town Square. Approximately two hundred people attended and the local children were involved through performing songs and dance.
