## RESTRICTIONS

### (what can I do / what can't I do)

- Regulations have been introduced throughout South Australia to protect lives and property during the bushfire season.
- They apply to everyone, not just those living in bushfire areas.
- It is essential that you are familiar with the regulations and understand what you can and cannot do, whether you are at home, on holiday or visiting a national park.

Once the Fire Danger Season has begun there are strict controls on the lighting of fires and the use of certain tools in the open. The restrictions remain in place until the end of the season.

When a Total Fire Ban Day is declared, there are further restrictions to what you can do.

Over the page is a table answering some of our frequently asked questions about fire restrictions.

### Explanation of terms in table:

\* A Schedule 9 or Schedule 10 Permit refers to a permit issued under the Fire and Emergency Services Act 2005.  
Your council fire prevention officer or CFS office can provide further advice.

\*\* An engine or vehicle exhaust system complies if:

- (a) all engine exhaust emitted by the engine or vehicle exits through the system; *and*
- (b) the system, or a device or devices forming part of the system, is designed to prevent the escape of burning material from the system; *and*
- (c) the system, or a device or devices forming part of the system, is designed to prevent heated parts of the system from coming into contact with flammable material; *and*
- (d) the system is in good working order.

\*\*\* "domestic premises" means a building or other structure that is fixed to the ground and connected to a reticulated or stored water supply and that is occupied as a place of residence but does not include a caravan.

<p><b>Q Can I light a fire without a permit?</b></p>	<p>In general, the only fires which do not require a permit are fires used for cooking, personal comfort. Fires for burning off, gas fired appliances and gas or electric welding equipment provided they are lit in accordance with the regulations and council restrictions applying to their use.</p>	<p><b>No</b></p>	
<p><b>Q Can I light a fire in the open air for burning off grass, stubble, weeds, undergrowth or other vegetation?</b></p>	<p><b>No</b> Unless you have obtained a Schedule 9 permit * from your local council.</p>	<p><b>No</b></p>	<p>Unless you have obtained a Schedule 10 permit * from your local council.</p>
<p><b>Q Can I burn off rubbish or grass cuttings?</b></p>	<p><b>Yes</b> Unless you have received permission from your local council, you must have:</p> <ul style="list-style-type: none"> <li>• A four metre cleared space around and above</li> <li>• A responsible person must be in attendance at all times with water or an extinguisher</li> </ul> <p><b>If you want to burn on the ground, you will require a Schedule 9 permit * from your local council.</b></p> <p>Check with your local council and the Environment Protection Authority, which also have control over the lighting of fires. Some councils have totally prohibited fires for waste disposal on domestic premises.</p>	<p><b>No</b></p>	<p>Unless you have obtained a Schedule 10 permit * from your local council.</p> <p><b>The lighting of incinerators is banned on a Total Fire Ban Day</b></p>
<p><b>Q Can I light a campfire, bonfire or light a fire for warmth or comfort?</b> (See special provisions for gas or electric barbeques below)</p>	<p><b>Yes</b> But only if:</p> <ul style="list-style-type: none"> <li>• In a properly constructed fireplace; <b>or</b></li> <li>• In a portable cooking appliance; <b>or</b></li> <li>• The fire is in a 30cm deep trench and no more than one metre square in area <b>and</b></li> <li>• You have a four metre cleared space around and above the fire</li> <li>• A responsible person is in attendance at all times</li> <li>• An adequate agent to extinguish the fire is at hand</li> </ul>	<p><b>No</b></p>	<p>Unless you have obtained a Schedule 10 permit * from your local council.</p>
<p><b>Q Can I use a gas or electric barbeque?</b></p>	<p><b>Yes</b> Providing you have:</p> <ul style="list-style-type: none"> <li>• A four metre cleared space around and above the gas fire</li> <li>• or electric element</li> <li>• A responsible person is in attendance at all times</li> <li>• An adequate agent to extinguish the fire is at hand</li> </ul>	<p><b>Yes</b></p>	<p>Providing it is gas or an electric element and used:</p> <ul style="list-style-type: none"> <li>• Within 15 metres of domestic premises <b>***, or</b></li> <li>• On a coastal foreshore</li> </ul> <p>Providing you have:</p> <ul style="list-style-type: none"> <li>• A four metre cleared area around and above the barbeque</li> <li>• A responsible person is in attendance at all times with water or an extinguisher at hand</li> </ul> <p>Some councils allow gas or electric barbeques in caravan parks or cleared picnic areas. Look for the signs or contact the council for advice.</p>

<p><b>Q Can I use a kettle BBQ?</b></p>	<p>Provided that:</p> <ul style="list-style-type: none"> <li>The BBQ is clear of all flammable material to a distance of at least 4 metres;</li> <li>A person who is able to control the fire is present at the site of the fire until it is extinguished;</li> <li>An appropriate extinguisher is at hand.</li> </ul> <p><b>Yes</b></p>	<p><b>No</b></p> <p>A solid fuel burning kettle BBQ (one that uses fuel such as wood, charcoal or heat beads) cannot be used unless you obtain a Schedule 10 permit from your local council.</p> <p>A gas-fired kettle bbq can be used if used within 15 metres of a domestic premises or on a coastal foreshore, providing that: The BBQ is clear of all flammable material to a distance of at least 4 metres;</p> <p>A person who is able to control the fire is present at the site of the fire until it is extinguished;</p> <p>An appropriate extinguisher is at hand.</p>
<p><b>Q Can I use a pizza oven?</b></p>	<p>Provided it is a gas or electric - see above for barbeques. If wood fired, it must comply with CFS code of practice for wood fired pizza ovens or obtain a schedule 9 permit* from your local council.</p> <p><b>Yes</b></p>	<p><b>No</b></p> <p>Unless it is gas or electric - see above for barbeques - or you have obtained a schedule 10 permit* from your local council</p>
<p><b>Q Can I drive a vehicle off road?</b></p>	<p>You can drive a vehicle within 2 metres of flammable bush or grass provided that the engine is fitted with an exhaust system that complies with the requirements listed over page. **</p> <p><b>Yes</b></p>	<p><b>Yes</b></p> <p>You can drive a vehicle within 2 metres of flammable bush or grass provided that the engine is fitted with an exhaust system that complies with the requirements listed over page. **</p>
<p><b>Q Can I have a fire in a National Park Reserve or a forest reserve</b></p>	<p>Strict regulations apply to all fires, including barbeques, in government reserves. <p><b>Q Can I use a chainsaw, grass trimmer, lawn mower or slasher</b></p>	<p>Provided that the engine is fitted with an exhaust system that complies with the requirements listed over page ** <b>and</b>:</p> <ul style="list-style-type: none"> <li>You have a four metre cleared space around the area <b>or</b></li> <li>The operator has a shovel or rake and a portable water spray in good working order.</li> </ul> <p><b>Yes</b></p>	<p><b>Yes</b></p> <p>Provided that the engine is fitted with an exhaust system that complies with the requirements listed over page ** <b>and</b>:</p> <ul style="list-style-type: none"> <li>You have a four metre cleared space around the area <b>or</b></li> <li>The operator has a shovel or rake and a portable water spray in good working order.</li> </ul>

<p><b>Q</b> Can I use a bird scarer in my orchard?</p>	<p><b>Yes</b> Providing that:</p> <ul style="list-style-type: none"> <li>the space immediately around and above the appliance is cleared of all flammable material to a distance of at least 4 metres;</li> <li>the bird scarer is constructed to prevent the escape of fire or burning material;</li> <li>the bird scarer is in good working order and clean so as to avoid a malfunction that could cause a fire;</li> <li>the person using the bird scarer takes precautions to ensure that the bird scarer cannot fall over, or be knocked over or otherwise interfered with by animals.</li> </ul>	<p><b>Yes</b> Providing that:</p> <ul style="list-style-type: none"> <li>the space immediately around and above the appliance is cleared of all flammable material to a distance of at least 4 metres;</li> <li>the bird scarer is constructed to prevent the escape of fire or burning material;</li> <li>the bird scarer is in good working order and clean so as to avoid a malfunction that could cause a fire;</li> <li>the person using the bird scarer takes precautions to ensure that the bird scarer cannot fall over, or be knocked over or otherwise interfered with by animals</li> </ul>
