Chief Executive's Quarterly Update

January to March 2017

The quarter January to March 2017 has seen a number of highlights.

Detailed assessment of storm damaged assets is now complete, with a funding application being lodged for State Treasury appraisal and assessment. Storm damaged assets represent approximately \$900,000 damaged road assets (with 50% funding sought) and approximately \$1.2 million damaged culverts / bridges / stormwater assets (with 50% funding sought).

Delivery of the new Mundoo Public Toilet facility is 90% complete. This new facility will provide new public amenities to Mundoo Boat Ramp users, Sugars Beach visitors and Hindmarsh Island tourists alike.

Our Environmental Action Plan has experienced 82% completion of ongoing tasks and work continues on the Local Action Plans for the Resilient Hills and Coast Climate Change Adaptation Project.



Alexandrina Council is supporting public amenity in a digital world with free Public WiFi now being installed at Centenary Hall, Goolwa Wharf and Goolwa Visitor Information Centre, with the installation of WiFi in the Strathalbyn Library underway.

The Fringe came to Alexandrina when the Adelaide Fringe Caravan rolled down south with a wonderful array of free Fringe acts on Sunday 12 March 2017, presenting to around 1,200 residents and visitors. This event also included partnering with Cittaslow Goolwa's 10th birthday, seeing a full day of free activities available and enjoyed by many.

Delivering on part of Council's Economic Development Strategy, the first Tourism and Visitor Strategy 2017-22 was endorsed by Council on 6 March 2017. This will be a guiding document for Council's support of a major industry in Alexandrina over the coming years.

In January, Mayor Parkes attended the celebration to recognise the South Lakes Golf Club's 50 year anniversary.

On 21 January, Mayor Parkes opened the 44th Compass Cup event and the following day attended the Milang to Goolwa Freshwater Classic.

Mayor Parkes and Interim Chief Executive, Victoria MacKirdy officiated at Australia Day celebrations at Strathalbyn and Goolwa, where Citizenships Ceremonies were conducted and Australia Day Awards were presented to community members.

Mayor Parkes attended Cittaslow events during the summer, including the 10th Anniversary celebration on 12 March. Local community group meetings which were attended by the Mayor included the Goolwa Ratepayers and Residents Association; The Marina Hindmarsh Island Boating and Tourism group; Goolwa Returned and Services League (RSL) and the Strathalbyn Community Action Planning group.





Organisational leadership to drive achievement of local and regional outcomes

On 16 January Council was advised of the closure of the Kalimna Hostel in Strathalbyn. Mayor Parkes and Council's administration continue to advocate for community needs with State and Federal Governments.

On 31 January, the Interim Chief Executive attended the Regional Development (RDA) Adelaide Hills, Fleurieu and Kangaroo Island Economic Development Forum in Strathalbyn.

On 6 March, the Interim Chief Executive attended an RDA Murraylands and Riverland Cluster Development workshop in Murray Bridge.

Mayor Parkes and the Interim Chief Executive attended a Department of Environment, Water and Natural Resources (DEWNR) and Murray-Darling Basin Authority (MDBA) key stakeholders workshop in Goolwa on 22 March.

On Saturday 25 March, the Fleurieu Aquatic Centre opened its doors to the public following decades of investigations, planning and a 21-month construction period. The \$21 million project was a joint initiative of the Alexandrina Council and City of Victor Harbor, with funding support from the Australian Government and State Government's Community, Recreation and Sport Facilities Program; and a generous land donation from Beyond Today. The two councils worked tirelessly together with community and key stakeholders to deliver this high-quality facility on time and on budget. The official opening of the centre took place the following week on Sunday 2 April 2017.

During this period Mayor Parkes attended the Southern and Hills Local Government Association (S&HLGA) Board Meeting at Penneshaw, Kangaroo Island; SA Regional Organisation of Councils (SAROC) and Local Government Association(LGA) Board Meetings in Adelaide; an Alexandrina Sustainable Agriculture Round Table meeting and a meeting of the Goolwa Wharf Precinct Board.

The Interim Chief Executive attended board meetings of Country Arts SA, Local Government (LG) Professionals SA and Local Government (LG) Professionals National.

Community Safety

Deliver an effective and efficient operational community safety service

In this reporting period there were a total of 46 dogs impounded. Twenty six were returned to their owner via the pound, 17 were returned directly to their owners, 3 were transferred to Council's Pound Contractor. Over this reporting period there were 7 feral cats trapped.

Over the upcoming quarter, development of the new Animal Management Plan will be a priority. This will involve community engagement, public consultation and for the plan to be endorsed by Council.

Roadside slashing program was completed early in the past quarter, this was slightly behind schedule due to extreme weather early in the season. Inspections and follow up of private properties in regards to fire prevention actions has occurred throughout the quarter.

In February the Fleurieu Bushfire Management Committee moved that the Bushfire Management Plan go out to public consultation. The consultation is running for 6 weeks ending in mid-April 2017.

The past quarter has seen a decrease in reports of abandoned vehicles. There have been 8 reports of abandoned vehicles for this quarter in which 3 have required removal by Council.

The Local Nuisance and Litter Control Act 2016 is being implemented in 2 stages. Litter control requirements came into effect this reporting period, while the Nuisance aspect will come into effect in July 2017. The roll out of this legislation has seen some section of the Local Government Act repelled.

Environmental Health

Deliver an effective and efficient operational environmental health service

Council continues to engage the services of the City of Onkaparinga to deliver immunisation services to the community. Over the last quarter the Meningococcal B vaccination study has commenced which will continue over the next 2 years.

In preparation for current septic tank de-sludging contract expiry in 2017/18 the Environmental Health team continue to work with the Sustainable Resources team to review the process and identify the most effective and efficient method of managing desludging of both private septic tanks connected to Septic Tank Effluent Disposal Scheme (STEDS) and Council infrastructure.





Environmental Strategy

Environmental Action Plan 2014-2018

As of the end of the quarter progress has been made against

Implementation priorities for remaining 18-month life of Environmental Action Plan have been determined. Outstanding actions will be considered during the Environmental Action Plan review in the second half of 2018.

Develop and implement progressive approach to climate change

The Resilient Hills and Coasts action plan implementation phase has now commenced and will progress for most of the 2016/17 year. The project partners will have Local Action Plans developed by June 2016. Regional Sector Agreement is to be signed in the next quarter.

Planning has commenced for Resilient Hills and Coast Solar Battery Bulk Buy project.

In accordance with the Council resolution a letter was sent to Minister Frydenberg in support of future funding for National Climate Change Adaptation Research Facility(NCCARF).

Council inventories finalised for 2012-2016 subject to final review of data integrity. Automatic capture of energy data through Balance Carbon Trellis platform is now occurring. The next steps are to set mitigation targets & develop business case for top priority mitigation project.

Develop and deliver program for protection of water resources

Work continues on a comprehensive mains water reporting system across the organisation. This project will continue throughout this financial year. It is anticipated that once implemented, this system will form the basis of decision making towards reduction targets and efficiency measures. The next step in this project is to develop internal data capture and reporting of recycled and licensed water use.

All new or upgraded facilities are afforded water saving technologies. Examples include Mundoo Boat Ramp Public Toilets in which water saving services are to be employed with rainwater tank supply. Designs for Soldiers Memorial Gardens Strathalbyn Public toilet refurbishment are well advanced, again employing water saving services technologies.

Council made a submission to the Northern Basin Review in February 2017 this project continues to be monitored. Council has also liaised with Department of Environment, Water and Natural Resources (DEWNR) regarding the amendment to boundaries of Coorong & Lakes Ramsar Listing.

Improve management of Council's environmental assets

Actions during the past quarter to work in partnership with Department of Environment, Water and Natural Resources (DEWNR), Natural Resources Management (NRM) and community stakeholders to protect and enhance local biodiversity on land have included:

- Dialog with stakeholders regarding Long-nosed fur seals in the Coorong and Lower Lakes
- On-going involvement in the Resilient Hills and Coast Climate Change Adaptation planning implementation process

Plans/policies/projects currently under development in regards to Council managed reserves and roadsides include:

- · Ratalang (Basham Beach) Master Plan,
- Tree Management Procedure,
- RMS Criteria Review & Survey

Council has endorsed and the process has commenced to place a Heritage Agreement over Borrett Road Lagoon.

Annual review of Goolwa Dunes & Tokuremoar Environmental Action Plan (EAP) has been undertaken with The Goolwa to Wellington Local Action Planning Association (GWLAP), Natural Resources Adelaide and





Mount Lofty Ranges (AMLR) and National Parks SA.

A mobile app being developed in collaboration with Council Geographic Information System (GIS) division to collect detailed data regarding third party biodiversity works occurring on Council land.

Work has been undertaken in collaboration with Obesity Prevention and Lifestyle (OPAL) to develop Sustainable & Healthy Catering Guidelines & to integrate more edible fruit trees in Council parks & gardens.

Work has commenced on Climate Change & Tree Risk project in response to direction from Local Government Risk Services.

Autumn 2017 edition of Clean Green Newsletter released.

A pilot project is currently underway with Fleurieu Regional Waste Authority (FRWA) to trial implementation of public place recycling in Goolwa.

Community Wastewater Management Systems (CWMS) & Water Recycling

Provide effective and innovative community wastewater management

Capital Expansion of Community Wastewater Management Systems (CWMS) Infrastructure Strathalbyn Lagoon Expansion project is till going through the design and process engineering stage with the aim to separate the civil works from the Mechanical and Electrical. This will expedite the Lagoon construction and diversion of flows from the Swamp Road lagoons.

Budgeted capital has been reallocated to Financial Year 2017-18 to suit the changes in construction timelines.

Recent changes to Department of Health process monitoring have also been included into this project to ensure compliance and cost optimisation.

The budgetary impacts on these changes are yet to realised as we will need to ascertain costs once we have tendered for the Mechanical and Electrical works.

Hydroplan is currently working on design for surface irrigation at Port Elliot Oval. The renewal will have to be worked through Infrastructure division and a Council approval process based on these initial evaluations.

Recent changes to process monitoring requirements at Waste water Treatment Plant (WWTP) from the Dept of Health will require systematic rollout throughout all our schemes. Mount Compass WWTP will be the first to be implemented to achieve the require levels for Defence Housing Australia (DHA) approval.

The Jubilee Estate Rising Main upgrade stage 2 has been awarded and will be completed in April. This pressure line has experienced years of poor performance due to blockages and unknown obstruction. Work will continue until the root cause is identified and eliminated.

Have installed pump renewals at Lady Emma Crt and Mark Lane Pump stations..

Numerous electrical maintenance and capital works are being implemented including, cabinet pressurisation fans, WWTP Hydrostatic level sensor conversion, Capital renewal of the Wolf Avenue pumping station, and Lakala Reserve soft starter panel construction.

We have identified an issue with the Gardiner St (Seachange) pumping main which runs through the Seachange Retirement Village. Engineering assessments have been completed for diversion of this line to the Jubilee Estate pumpining main. We are hoping this will be completed by the end of the financial year.

Pt. Elliot Flushing Program is due to start as of next week. This wil run for the remaining of this Financial Year. Letters have been sent out to residents and have already started receiving calls requiring further information. Another busy 3 months regarding CWMS Pump Station Alarms. We have responded to 160 Alarms, with 78 coming after hours during the third quarter. Have also been kept busy with 8 Rising main breakages during Jan-Feb alone. Have been experiencing some major issues on our Stormwater Reuse main. Have been concentrating on closing out a lot of our Maintenance Work Requests before our resources shift to our Flushing Program. We have closed out approx. 160 requests in the last 3 months and are down to only 32 requests outstanding. (down from 100+ during January)

2016/17 Storm Damage

Detailed assessment of storm damaged assets is now complete, with Council performing the initial asset assessment of damaged infrastructure. A funding opportunity was identified thorough State Treasury Department for Disaster Recovery Funding which required additional independent assessment of damaged assets. This independent assessment is now complete and a funding application has been lodged for State Treasury appraisal and assessment.

Storm damaged assets represent approximately \$900,000 of damaged road assets (50% funding sought) and approximately \$1.2 million of damaged culverts / bridges / stormwater assets (50% funding sought). Capital expansion and renewal programs have been substantially revised across the majority of asset classes to reflect, and accommodate, substantial resource and financial commitment required to deliver storm damage works during 2017/18 & 2018/19 as required.

Project Updates

The Delivery of capital and renewal capital projects is progressing in accordance with Long Term Financial Plan and Annual Business Plan.

2016/17 sealed and sheeted road renewal programs are 90% complete, with final works occurring in 4th quarter. 2016/17 footpath expansion & renewal program is approaching 95% complete, with final works occurring in 4th quarter.

The Nine Mile Road, Strathalbyn road project has now commenced with the contract awarded in April 2017 and works delivery committed to by 30 June 2017. This project represents a substantial design & specification commitment by Infrastructure & Assets Department, representing 5.8 km of design work and contract value approaching \$1.5 million. Department of Planning Transport & Infrastructure have made available a \$900,000.

Special Local Roads Funding contribution to Council, to realise this project. Sandergrove Road, Strathalbyn Power Line Environment Committee (PLEC) Stage 1 project to underground street lighting is now underway following a substantial design commitment from the Infrastructure & Assets Department. PLEC Stage 1 works represent a \$1.2 million contract value (50% funded). Council support for PLEC Stage 2 has been secured with PLEC Stage 2 design & specification works now substantially commenced, for works roll-out in late 2017.

The Mount Compass Streetscape Project (at IGA frontage) has now commenced and is due for completion by the end June 2017.

Facilities & Building Project Update

Delivery of the new Mundoo Public Toilet facility is 90% complete, this new facility will provide new public amenities to Mundoo Boat Ramp users, Sugars Beach visitors and Hindmarsh Island tourists alike. The works are expected to be complete by end of May 2017 with on-ground works having required substantial project management due to sensitive surrounding environment and many State Government agencies having provided referral advice.

Design and specification works associated with Commercial Road, Strathalbyn Public Toilet renewal project is substantially underway, with architectural and services plans 95% complete. The works contract will be called during May 2017, with works to commence during Winter 2017 to minimise public disruption.

A full structural assessment of Goolwa Wharf is being undertaken and is expected to be completed by the end of May 2017. The structural report will inform priority works as Infrastructure & Assets look to commence substantial Wharf renewal works in the 2017/18 financial year.

Building Rules Assessment

Building Inspections

For the period a total of 106 inspections were carried out, including 77 structural frames (includes 15 follow up inspections) and 24 swimming pools (includes 11 follow up inspections)

There are many difficulties in achieving the required level of inspection for swimming pools, including the need to conduct investigations where no notification has been made. Swimming pool safety barriers are almost always constructed by the owners and Council often received limited documentation.

The requirements of the building & swimming pool inspection policy have been satisfied.

Building Fire Safety Committee

For the period 8 premises were inspected with 5 of those being inspected by the full Committee. Progress on fire safety upgrades is monitored closely with the next meeting scheduled for 9 June 2017.

Building Rules Advice and Assessment

Councils building section has issued consents for 145 building rules applications out of a total of 222 building consents granted in the Council area for the period (including private certification). This equates to 65% of all building consents being assessed by Council building surveyors. The consents included 46 new dwellings and 13 dwelling additions.

The total number of building rules consents issued was down by 1% when compared with the same period last year. The development applications for this period involved a higher percentage of minor class 10 buildings (verandah/carport/garage etc.) when compared to the number of new dwellings and dwelling additions. New dwellings were down by 39% and dwelling additions were down by 23% when compared to the same period last year.

Strathalbyn Township and Environs Development Plan Amendment - Update
Following the Minister's approval of the Statement of Intent for the Strathalbyn Township and Environs
Development Plan Amendment in December 2016, work has commenced on the required investigations for
the Development Plan Amendment (DPA). To date the following has occurred:

• Preparation of project scope, tender process, appointment and commencement of the Strathalbyn District Centre Traffic, Car Parking and Streetscape Plan. A very successful consultation was undertaken over 2 and half days with the community and targeted stakeholders including the traders. Further details on the consultation will be presented at the meeting.

Armed with this information the consultants will now develop traffic management and car parking reports, detailed concept plans and draft streetscape designs. This will be completed in May following which further consultation will occur before a final report is presented by the end of June.

• Preparation of the project scope and tender process for Lot 10 Langhorne Creek Road Master Plan. Applications close on 11 April 2017 with the project commencing shortly thereafter.

Goolwa Growth Area - Enquiry By Design

Following endorsement of the Enquiry By Design Outcomes Report at the 21 November 2016 policy committee meeting and subsequent endorsement by Council in December 2016, two community information days were held on 16 December 2016 and 11 January 2017, to inform the community about the outcomes of the report. The two days were well attended with approximately 100 people dropping in. Overall the feedback was very positive about the future plans for Goolwa.

Meetings have also been held with the land owners to discuss next steps which have subsequently resulted in two meetings occurring with the Department of Planning, Transport and Infrastructure(DPTI). With the partial introduction of the Planning, Development and Infrastructure Act (PDI Act) on 1 April 2017 advice from DPTI has been to not progress any new Development Plan Amendment processes under the Development Act as they want Councils to start transitioning to the new Planning and Design Code (Code). Knowing that the background work has been done and the key land owners are on board with the project DPTI are assisting Council in commencing the development of the rezoning in line with the new Code format. We are currently awaiting further information from DPTI in order to commence this.

Planning, Development and Infrastructure Act - Update
Parts of the Planning, Development and Infrastructure Act (PDI Act) came into effect on 1 April 2017. The
key elements that have been introduced are as follows:

- Appointment of the State Planning Commission
- Establishment of Joint Planning Boards there was a recent announcement from the Department of Planning (DPTI) of grant funding being offered to councils to establish Joint Planning Boards. As a result of this contact was made with Victor Harbor, Yankalilla, Mount Barker and Onkaparinga Councils to see if there was any interest in discussing this however at this point the general feeling is to take a watching brief, however all are willing to discuss further as things unfold with the Act implementation. There has been no indication that Councils will be forced into this and it is understood that the focus for the pilot project funding is for the areas outside of the Greater Adelaide Region such as the Riverland and the South East where regional Development Assessment Panels are already in existence and where a State Regional Plan does not exist like the 30 Year Plan for Greater Adelaide.
- Commencement of the Environment and Food Production Area DPTI is sending out a letter to all affected land owners and will be having a community information session at Mount Barker.
- Creation of the Community Engagement Charter and the SA Planning Website
- Infrastructure Schemes





- Various ancillary or administrative parts that will allow for delegations, advisory committees, professional standards etc to be established.
- The relevant regulations to allow these things to occur have also been released.

In summary, the portions of the PDI Act that commenced on 1 April 2017 are intended to allow the "back bone" of the new planning system to form. The new State Planning Commission will be formally established and will be able to commence its work on developing the new Community Engagement Charter, State Planning Policies and the Planning and Design Code. Joint Planning Boards and Essential Infrastructure Schemes will be able to be tested and established, whilst the SA Planning Portal can evolve.

Recent correspondence from the Local Government Association (LGA) has advised that DPTI is seeking within the 2017/18 financial year a contribution from Councils to establish the Planning Portal which is in accordance with the provisions of the PDI Act. As Council's annual value of development is between \$50 and \$100 million our contribution has been calculated at \$28,000. It is expected that more information will be forthcoming shortly from DPTI of which the LGA will keep Councils informed.

Development Plans, development assessment and enforcement will continue to be governed by the Development Act. Those portions of the PDI Act concerning the new Planning and Design Code, development assessment and enforcement have not yet been proclaimed.

With respect to the Planning and Design Code, meetings with DPTI have indicated that their intention is to have the code completed by the end of 2018. This is going to require Councils to undertake some transition planning to determine how our current Development Plans will translate into the new code format. This will then identify any gaps or where additional work is required. DPTI have indicated that they intend to allocate a specific staff member to assist each Council with this process.

Electronic Assessments

With the resolution of applying electronic signatures the department have been able to successfully assess and issue decision notification forms for all land division applications fully electronically. The workflow for this is functioning really well and as a result we are currently working with a private certifier company to commence processing privately certified applications electronically as well.

Minor Project Reporting

World Heritage Bid

Status Update: The project team were successful in completing the national nomination documentation in time to submit by 17 February 2017. Prior to submitting the nomination, Rebekah Sharkie hosted an event in Canberra where the project team were able to showcase the bid to key personnel. It is expected that a decision as to whether the nomination will be put on the shortlist for assessment by the end of June 2017.

Customer Services

Deliver excellence in customer service

During the January to March 2017 period the Service Centre was received 11,644 phone calls. A total of 5,358 council payments were processed, 80% being over the phone and in person and the remaining 20% paid via online means.

82% of calls received to council were answered within 30 seconds, achieving our target of 70% of calls presented to council answered within 30 seconds.

The call abandonment rate for the quarter was 2.68%, well under industry standard of 4% and the average call talk time being 2 min 14 seconds, consistent with previous quarter.

A total of 519 Property Search requests were processed, an increase of 6% from the previous quarter.

Supporting Councils Community Strategic Plan Aspiration - Innovate throughout our Region - Proactive Leadership and Accountability, by maintaining a high performing, dynamic organisation responsive to community interests.

Creating a Culture of Customer Service Excellence

Council has embarked on an organisation wide Customer Service training program to foster and enhance a culture of Customer Service Excellence. This program will be delivered during April and May 2017.

Two new community support services were introduced and training delivered to staff in February. The National Relay Service (NRS) is an Australian Government initiative that enables people who are deaf, or who have a hearing or speech impairment, to make phone calls using a wide range of communication devices.

TIS - Telephone Interpreting Service is also a Government initiative to assist members of the community who may have a language barrier and require assistance when interacting with council staff.





Supporting Fortnighly Waste Collection

The Customer Service team continues to provide valuable support to our residents as they embrace recent changes with the implementation of councils fortnightly kerbside waste collection.

64 Exceptional Circumstances applications were processed compared to 78 in the previous quarter and a total of 233 composting products were sold to Alexandrina residents from Council's Goolwa office and Strathalbyn Library.

Since implementation of the Fortnightly kerbside waste effective 1 July 2016, Council has supported residents to embrace these changes by approving 816 Exceptional Circumstances applications. At the same time we commenced the sale of compostable materials, to date we have sold 342 Compost Bins, 270 Worm Farms, 477 Kitchen Caddy's and 348 replacement bags.

Libraries - Programs and Services

Alexandrina Libraries

Alexandrina Libraries ran a Stop-Motion competition for young members of the community between the ages of 8 to 16. Some of the positive outcomes around the competition were that it created an opportunity for parents to create something with their children, it allowed these young people to demonstrate their skills and creativity and it involved early teens, particularly boys, who are otherwise quite disengaged from the Library. Tutorial classes were offered to interested entrants. 4 entries were submitted and the recipient won an iPad to continue their creative pursuits.

The Library team are investigating the use of the GoChip Beam, a device that allows users to borrow a portable Wi-Fi hotspot that contains up to five movies on it. The trial is provided free from Public Library Services with loanable devices to fully test its capabilities and viability in this environment and community.

8 new digital resources have been added to history room computers to assist genealogy researchers. 716 images are now available for the public access through our Snapshots in Time Project with volunteers providing much of the time to upload the images and data.

1704 items were added to the collection in this quarter, of which 359 were Adult Fiction, 309 DVDs, 262 Adult Non-fiction, 256 Children's books, 96 magazines (plus 26 local history magazines), 85 Large Print books, 58 CDs, 52 Audiobooks, 41 Teen books, and 17 Local and Family History books and databases.

New face out shelving was installed in the Children's area at Goolwa late last year and has proved to be a worthwhile investment. In the three months prior to the new shelves approximately 107 items circulated, as selected from the pre-existing spine out shelving. In the three months since the new face out shelving was installed 412 items circulated. That is an increase of over 300 items, an increase of 285%, we will investigate other ways we can face out our stock to promote more effectively.





Innovative use of Library spaces

Alexandrina Libraries continue to utilise available space in different ways to provide a variety of activities for the community to be involved with and use the space.

The 'Grow Free' market place expo style event transformed the Community Centre at Strathalbyn Library into a vibrant community trading hall, with activities happening off to the side in the smaller rooms. 'Living Without Fingerprints' at Goolwa utilise the tried method of moving aside the audio visual, youth, and children's shelving to create an event space.

Library Programs - Strathalbyn Community Market Place

The Strathalbyn Library Community Centre was transformed into a 'market place' on Saturday 4 March from 10am-1.30pm. An estimated 200-250 people passed through the doors throughout the 3.5 hour period.

This was an unbookable event and involved working closely with a loose-knit and predominantly online community group. The result was a colourful, happy & vibrant event, attended by a very enthusiastic and passionate group of people from diverse backgrounds, A large number of young families and children were present and many came from as far as Adelaide, Victor Harbor, Mount Barker and Murray Bridge.

The event included tables of giveaway produce (fruit, herbs, vegetables, flowers, seedlings), a display of library books available for loan and a kids' corner. A table featuring seed-bomb making was set up outside the building which was adorned with welcoming colourful flags.

Four gardening talks were held in the Angas Room with 50-55 guests attending each talk. While the talks took place, people flowed in and out of the Community Centre for the entire 3.5 hour period and engaged with the 'Grow Free' members who were positioned at each market table. We heard many reports of people meeting each other for the first time and making new connections and friendships.

Positive comments were received and circulated on social media. An amateur photographer who attended posted pictures on the Grow Free Facebook page which has 3000 members.

Alexandrina Visitor Services staff networked with tourism operators new and ongoing to ensure their details were current and correct for online content in the lead up to the busy Easter period.
