NOTICE TO APPLICANT

IT IS THE RESPONSIBILITY OF EVERY DOG OWNER

Ensure every dog 3 months of age or over is registered as required by law.

To renew your dog's registration between 1 July and 31 August each year.

The penalty for keeping an unregistered dog is an \$170.00 expiation fee.

A limit of two dogs applies per property.

Council permission is required to keep more than 2 dogs as per this form.

You must be 16 years of age or over to register a dog in your name.

ASSESSING YOUR APPLICATION

In order to assess your application, Council will or may require the following -

A site inspection of the property where the dogs are kept may be required to be undertaken by a Community Safety Officer to determine whether the property is suitable to house the number of dogs applied for.

A letter from each neighbouring property owner, stating that they have no objection to you having more than two dogs on your property.

How you will dispose of dog waste.

Council will contact you by mail with an assessment of your application. Successful applicants will be notified by mail. Requests for further information will be notified by mail.

PERMISSION WITHDRAWN

The permit may be withdrawn, by written notice, if -

Dogs other than those approved are kept on the premises for longer than 14 days.

Objections are raised by neighbouring residents or property owners.

Dogs are not properly cared for or controlled.

Dogs are not kept registered and wearing a current registration disc at all times.

Dogs are not confined to the property at all times unless under the control of a responsible person.

Barking dog complaints are lodged with Council

Alexandrina Council Officers are refused entry for a site inspection
